**\*NOTE:** There are 11,852 distinct deaths of U.S. residents reported in VAERS through 9/10/2021, many of which occurred after multiple vaccines were administered during the same medical appointment. Therefore there are 18,295 instances of death following vaccinations reported when displayed by vaccine type. But each value displayed in this report includes only distinct patient records (no duplicates) and percentages are calculated as a percent of total patient reports received. For instance, if a patient received influenza, measles, and pertussis vaccines during the same office visit, that patient's record would populate three instances in three categories on this report.
