**\*NOTE:** There are 12,550 distinct deaths of U.S. residents reported in VAERS through 10/1/2021, many of which occurred after multiple vaccines were administered during the same medical appointment. Therefore there are 19,141 instances of death following vaccinations reported when displayed by vaccine type. But each value displayed in this report includes only distinct patient records (no duplicates) and percentages are calculated as a percent of total patient reports received. For instance, if a patient received influenza, measles, and pertussis vaccines during the same office visit, that patient's record would populate three instances in three categories on this report.
